## **Equality Statement**

### Legal Duties

As a school we welcome our duties under the Equality Act 2010. The general duties are to:

- eliminate discrimination
- advance equality of opportunity
- foster good relations

We understand the principle of the Act and the work needed to ensure that those with protected characteristics are not discriminated against and are given equality of opportunity.

A protected characteristic under the act covers the groups listed below:

- age (for employees not for service provision),
- disability
- ethnicity
- gender
- gender reassignment
- maternity and pregnancy
- religion and belief, and
- sexual identity
- Marriage and Civil Partnership (for employees)

In order to meet our general duties, listed above, the law requires us to do some specific duties to demonstrate how we meet the general duties. These are to:

Publish equality information – to demonstrate compliance with the general duty across its functions.

We will not publish any information that can specifically identify any individual child or adult.

Prepare and publish equality objectives.

To do this we will collect data related to the protected characteristics above and analyse this data to determine our focus for our equality objectives. The data will be assessed across our core provisions as a school. This will include the following functions:

- Admissions
- Attendance
- Attainment
- Exclusions
- Prejudice related incidents

Our objectives will detail how we will ensure equality is applied to the services listed above however where we find evidence that other functions have a significant impact on any particular group we will include work in this area.

We also welcome our duty under the Education and Inspections Act 2006 to promote community cohesion.

We recognise that these duties reflect international human rights standards as expressed in the UN Convention on the Rights of the Child, the UN Convention on the Rights of People with Disabilities, and the Human Rights Act 1998.

In fulfilling our legal obligations we will:

- We observe good equalities practice, including staff recruitment, retention and development.
- We aim to reduce and remove existing inequalities and barriers.

## **Our Ethos/mission**

Borden CE Primary School aims to create a happy, secure and Christian learning environment for all members of our school community.

- We will deliver a challenging and enjoyable curriculum, which provides opportunities for all children to meet their personal goals, and which recognises the value of sport, diverse cultures, the arts and the sciences.
- We will endeavour to keep the children safe in a secure school environment, to educate the children to support their future safety and to work closely with all appropriate agencies to ensure that children at risk of harm are identified and supported.

- Children will be encouraged to value and support their families, school, church, local community and society. Positive behaviour will be promoted and the children's support of others will be recognised and valued.
- We will provide a broad and balanced education and encourage the children to make choices which will enable them to access future educational opportunities and which will help support their economic well-being. As a Church of England school we recognise the importance of our faith. Underpinning all the aims for our school is our belief that Borden CE Primary School - through example, knowledge, fellowship and worship we can nurture a love of God and accept His support and guidance in all that we do.

#### **Addressing Prejudice Related Incidents**

This school is opposed to all forms of prejudice and we recognise that children and young people who experience any form of prejudice related discrimination may fare less well in the education system. We provide both our pupils and staff with an awareness of the impact of prejudice in order to prevent any incidents. If incidents still occur we address them immediately and report them to the Local Authority using their guidance material. The Local Authority may provide some support.

#### **Responsibility**
